



**APPLICATION FOR GRAIN WAREHOUSE LICENSE**  
**PUBLIC SERVICE COMMISSION**  
 SFN 9470 (Revised January 2016)

A grain warehouseman must obtain an annual license from the North Dakota Public Service Commission for each public warehouse in the state. North Dakota Century Code Chapter 60-02.

A business organization or sole proprietor using a trade name other than its given name must be registered and in good standing with the ND Secretary of State. A partnership must file a copy of its partnership agreement if not registered with the ND Secretary of State. An application for license must be complete and include.

1. A license fee as required in NDCC section 60-02-07.
2. A surety bond with valid power of attorney from surety attached. See bond schedule found in North Dakota Admin. Code section 69-07-02-02.
3. A copy of the scale ticket, warehouse receipt (if used), each type of credit-sale contract (if used), storage and handling policy, and conversion policy (if applicable).
4. A bin diagram and bin chart of the warehouse.
5. Proof of grain insurance - see section 60-02-35.
