### **PSC Schedules Public Hearing in Watford City for Proposed Crude Oil Pipeline**

BISMARCK, ND – The North Dakota Public Service Commission (PSC) will hold a public hearing in Watford City on Friday, Oct. 7, regarding a proposal for a crude oil pipeline in McKenzie County.

Caliber Bear Den Interconnect, LLC, has submitted an application for a permit for a new 5.3-mile long, 12.75-inch diameter crude oil pipeline and associated facilities in McKenzie County. The pipeline would transport crude oil from Enable Midstream's Devore Terminal to the Dakota Access Pipeline's Watford City Terminal. The pipeline will have a maximum capacity of 75,000 barrels per day with a normal throughput of 50,000 barrels per day. The estimated cost of the project is approximately \$12 million.

The proposed route follows U.S. Highway 85, beginning approximately 7.6 miles south of Watford City and ending approximately 2.9 miles south of Watford City near the junction of U.S. Highway 85 and the U.S. Highway 85 bypass. This hearing will be conducted by a substantive Administrative Law Judge (ALJ). The ALJ will conduct the hearing and related proceedings and issue a recommended findings of fact and conclusions of law and a recommended order. The PSC Commissioners will review all the information in the record and make the final decision on the case at a later date.

The hearing provides an opportunity for members of the public to contribute to the PSC's official record. Any comments from members of the public must be received at the hearing to be part of the record. People with concerns, questions or support/opposition for the project are encouraged to attend the hearing and present the information. Information received after the hearing will not be part of the official record and cannot be used as a basis for the Commission's decision unless certain additional procedures are followed.

The North Dakota Public Service Commission is a constitutionally created state agency with authority to permit, site and regulate certain business activities in the state including electric and gas utilities, telecommunications companies, power plants, electric transmission lines, pipelines, railroads, grain elevators, auctioneers, commercial weighing devices, pipeline safety and coal mine reclamation.
