
MIDCONTINENT COMMUNICATION'S PETITION FOR APPROVAL OF
AGREEMENT

On January 10, 2008, pursuant to 47 U.S.C. § 251(f)(1)(B) Midcontinent Communications ("Midcontinent") filed a Notice of Bona Fide Request for wholesale resale of telecommunications services that the North Dakota Telephone Company ("NDTC"), the incumbent local exchange carrier for the Rugby exchange, provides at retail to subscribers who are not telecommunications carriers for the Rugby exchange and also for facilities based interconnection for that exchange. Thereafter, Midcontinent and NDTC voluntarily entered into an AMENDEMENT TO INTERCONNECTION AGREEMENT. Said agreement is marked as Exhibit "A" and attached hereto.

WHEREFORE, Midcontinent requests that the Commission enter an Order approving the AMENDEMENT TO INTERCONNECTION AGREEMENT pursuant to 47 U.S.C. § 252(e)(1).

AMENDMENT TO INTERCONNECTION AGREEMENT

THIS AMENDMENT TO INTERCONNECTION AGREEMENT ("Amendment") is effective as of the March 31, 2008 (the "Effective Date"), by and between Midcontinent Communications, a South Dakota Partnership ("Midcontinent") with offices at 5001 West 41st Street, Sioux Falls, SD 57106 and North Dakota Telephone Company ("NDTC") with offices at 211 22nd St NW, PO Box 180, Devils Lake, ND 58301. This Amendment may refer to either NDTC or Midcontinent or both as a "Party" or "Parties."

W I T N E S S E T H

WHEREAS, NDTC is a local exchange telecommunications company authorized to provide telecommunications services in the state of North Dakota; and

WHEREAS, Midcontinent is a competitive local exchange telecommunications company authorized to provide telecommunications services in the state of North Dakota; and

WHEREAS, the Parties have entered into an agreement (the "Agreement") pursuant to Sections 251 of the Telecommunications Act of 1996 ("the Act") for the purposes of resale of NDTC service, and that agreement has been approved by the North Dakota Public Service Commission (the "Commission"); and

WHEREAS, the Parties wish to interconnect their facilities and exchange Telecommunications Traffic specifically for the purposes of fulfilling their obligations pursuant to Sections 251 of the Act.

NOW THEREFORE, in consideration of the mutual agreements contained herein, NDTC and Midcontinent agree as follows:

1. Substitution of Amended Terms and Conditions

Upon approval of this Amendment by the Commission, the Parties shall substitute the following documents attached hereto for the corresponding documents in their current Agreement:

1.1 General Terms and Conditions

1.1.1 Section 2.2

The resale and facilities based provisions of this Agreement shall be effective in the Rugby exchange on March 31, 2008 and July 31, 2008 respectively.

1.2 Resale Attachment 1 Exhibit B – Area of Resale - Attached

1.3 Interconnection Attachment Section 2.4.1.1.1

The Parties will establish local trunk groups for the exchange of Local/EAS Traffic and ISP Bound Traffic (“Local Interconnection Trunks”) on the Direct Interconnection Facility. One Local Interconnection Trunk Group will be established for each exchange where CLEC is competing. The Parties agree that all Local/EAS Traffic and ISP Bound Traffic exchanged between them will be on trunks exclusively dedicated to such traffic. Neither Party will terminate InterLATA toll traffic or originate untranslated traffic to service codes (e.g. 800, 888) over Local Interconnection Trunks.

1.4 Pre-Ordering and Ordering Attachment Section 2.2

- 2.2.1 The New Service Provider (NSP) shall place simple or complex orders for services by submitting a Service Order (“SO”) to the Old Service Provider (OSP). A simple order request is defined as a port only request that (1) does not involve unbundled network elements (2) involve an account only for a single line (3) does not include complex switch translations (e.g., Centrex, ISDN, AIN services, remote call forwarding, or multiple services on the loop/line) (4) does not include a reseller. All orders not meeting these criteria shall be complex orders.
- 2.2.2 The required Simple Port Service Request (SPSR) fields consist of: Account Number, Telephone Number, Pass Code (if applicable), and Zip Code. The Parties agree to also include the customer name and address, Customer Carrier Name Abbreviation, Purchase Order Number, Desired Due Date/Time, Requisition Type, Company Code, Telephone Number (Initiator), End-User Line Treatment, New Network Service Provider, Supplemental order notice and Version, if applicable to aid in provisioning of the simple port order request.
- 2.2.3 The New Service Provider must submit requests for all Complex Ports on the ATIS OBF Standard Local Service Request (LSR) Form.
- 2.2.4 The OSP shall bill the NSP a service order charge as specified in the Pricing Attachment for each SO submitted, regardless of whether that SO is later supplemented, clarified or cancelled. An

individual SO will be identified for billing purposes by its Purchase Order Number ("PON")

2.2.5 Orders containing less than 5 lines whether simple or complex shall be provisioned using standard intervals.

1.5 Ancillary Services Attachment

Section 1.1

ILEC utilizes Ramsey County and Pierce County for the provision of 911/E-911 services. The CLEC is responsible for connecting to Ramsey County and Pierce County and populating Ramsey and Pierce County's database. All relations between County and CLEC are totally separate from this Agreement and ILEC makes no representations on behalf of Ramsey and Pierce County.

1. Continuance of Current Arrangements
2. The current Agreement shall remain in effect until such time as this Amendment is approved by the Commission.


