NOW, THEREFORE, BE IT RESOLVED, by the supervisors of Fairbanks Township, North Dakota, that:

1) The petition heretofore described praying for the vacation of the alley that runs north and south between Lots 1 and 2 on the east side and Lots 11 and 12 on the west side, in Block 2 of the Village of Norma, North Dakota is all in things approved and granted;

2) That said portion of the alley is hereby declared vacated, subject to the rights of any franchises, their successors and assigns, heretofore granted by the village of Norma, North Dakota and not heretofore waived or abandoned;

3) That this resolution shall be published in the manner described by law and a copy of it, together with a plat showing the location of said alley, be recorded in the office of the recorder in and for Renville County, North Dakota.
