Commissioner Lindstrom attended a regional meeting presented by the North Dakota Department of Transportation regarding Title VI requirements. Additional information will be available this fall.

No response was received at the time of this meeting regarding the shoreline deterioration noted at Golden Lake.

A letter was received in response to the fine imposed for the removal of a tree at Golden Lake.

The commission agreed to leave the fine as initially determined, noting that a tree was removed from a publicly-owned park without prior approval.

The North Dakota Department of Transportation did not give advance approval for the proposed county road #5 project. Mike Basingthwaite of Interstate Engineering has agreed to contact the local government division to explain that the commission understands that bonds will need to be issued and a tax levy generated to pay for the project.

Public Safety Coordinator Don Huso met briefly with the commission. He explained that currently FEMA has depleted the funds available for disaster relief.
