Local athletes headed to Optimist Volleyball Series

While many graduated athletes are looking ahead to summer training programs, our local volleyball players are getting set to make a final high school competition memorabilia. Jenny Erhardt, Allison Opp and Jenna Maas were selected as a 12-person West All-Stars roster for the annual North Dakota Optimists and North Dakota High School Coaches Association sponsored Class All-Star Volleyball Series. Beulah's Brenna Johansen was also selected as an alternate to the West team.

The matches will be at 7 p.m. Monday, June 21 at the Fargo North High School gym and Tuesday, June 22 at the Bismarck High School gym. Twenty-four talented, graduated senior girls from across the state will be participating in the match.

During Erhardt's senior season, she led Center-Stanton with 402 kills, 72 aces, 378 digs and 79 blocks as the Wildcats were the Region 5 runner-up in a tight match against Flasher. She also became C-S's first volleyball player to total a career 1,000 kills and 1,000 digs.

Hazen's pack of Opp and Maas were obvious choices to the prestigious series. From her outside hitter position, Maas collected 244 kills, 46 aces, 148 digs and 44 blocks in 2009 for the Bison. She also accumulated a career serving percentage of 95.6 percent.

Opp, with four years varsity experience at the middle hitter, smashed Hazen career totals with 2,772 career kills. In the 2009 season, Opp had 382 kills, 90 aces, 158 digs and 72 blocks as the Bison placed second at the state tournament.

Johansen led the Miners with 88 aces, 431 kills and 370 digs while playing in 119 of 122 sets last fall. She was an all-district, all-region and all-Coal Country selection as Beulah advanced to fourth place in the Region 7 Tournament.

Admissions are \$5 at the door for adults, \$3 for students, and children age 12 and under are free.

Optimist Clubs are dedicated to serving youth. Net proceeds of this event will be used to provide scholarships to volleyball players and support youth projects throughout the state. All four athletes plan to continue their competitive volleyball careers at the college level this fall.

DOH allows reusing damaged utility poles

The North Dakota Department of Health is encouraging the proper reuse and management of damaged utility poles, according to Ted Poppke, environmental scientist with the Department of Health.

"Many of the utility poles that were knocked down or damaged during winter storms earlier this year are being reused by farmers, ranchers and others," Poppke said. "While we encourage the recycling or reuse of these materials, we do want to make sure people handle them safely."

Most utility poles and cross arms have been treated by one of several methods to extend the service life of the pole. This treated wood should not be burned in open fires or in stoves, fireplaces or residential boilers because toxic chemicals may be produced as part of the smoke and ashes. In addition, treated wood should not be used where it may come into contact with humans or food sources – including playgrounds or play areas, vegetable gardens and agricultural production and storage areas – or where it may come into direct or indirect contact

with drinking water supplies.

The galvanized steel pins that hold ceramic or plastic insulators on the utility poles have threads made of lead. If swallowed, lead and lead dust can cause adverse health effects, including behavioral problems, learning disabilities, miscarriage, seizures and death. Children 6 and younger and pregnant women are the most at risk for the dangers of lead.

Anyone collecting broken utility poles or parts should handle the lead-containing metal components as little as possible. Because it is toxic, lead cannot be disposed of in the garbage or a landfill. Instead, the parts that contain lead must be separated for recycling. The DOH's Division of Waste Management has a list of metal recyclers that may be interested in recycling the lead. Ceramic or plastic insulators that are entirely free of metal, including lead, may be reused, recycled or disposed of in an inert or municipal solid waste landfill.

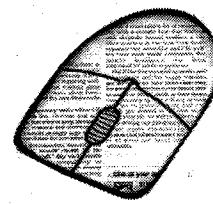

Christianson moved to dispense with the reading of the minutes and approve as presented. Rudningen seconded the motion, all voting aye, motion carried.

Rudningen moved to dispense with the reading of the treasurers' report and approve as presented. Motion seconded by Olin. Roll call voting, all voting aye, motion carried.

Olin moved to approve and pay bills in hand. Christianson seconded the motion. Personal Appearance by Frances Pulver requesting use of the City land west of town for the wagon train to park over Old Settler's was discussed. Christianson moved to grant them permission, seconded by Rudningen. Motion was carried by all voting aye.

Gearl Fenster was present to request permission to dig into the street for access to the main sewer line at the Lot 3, Block 2, Hazel Miner addition so his sewer line would not have to cross his water line. Olin moved to allow Fenster's to cut into the curb and street and repair at their own expense. Rudningen seconded the motion. Roll call voting, all voting aye, motion carried.

Daren Peterka with Interstate Engineering was present to discuss drainage in the Hazel Miner addition. Daren will contact Mr. Hovey and let the City know when they are to meet to discuss drainage. SRF payment estimate of \$1520.00 to terminate sample tap is to receive a credit of 137.50 to balance the SRF account to zero. A letter with the

final date of control panel changes and project finished was drafted. Olin moved to approve the SRF credit and letter after panel is checked. Rudningen seconded the motion. Roll call voting, all voting aye, motion carried.

Susan Cahoon with Cahoon's Bar & Grill was present to ask for a beer garden on June 11th & 12th in front of their bar. The ropes will be moved to the west side of Cahoon's. Christianson moved to approve the beer garden per their request and wristbands will be mandatory and a bouncer. Rudningen seconded the motion. Roll call voting, Christianson - aye, Rudningen - aye, Olin - nay, motion carried.

First on the agenda for old business was the highway closure for Old Settler's. We will detour traffic at the corner of Square Butte Street and Center Avenue. We will post a sign to allow diner traffic thru and have a full block on the north side of the alley.

Sound systems for the civic center were next on the agenda. Premier Audio's bid was \$8,345.00, Dakota Sound 17,410.00, and Ebel \$15,918.00. Olin moved to approve Premier Audio's bid for \$8,345.00. Rudningen seconded the motion. Roll call voting, all voting aye, motion carried.

JDA signs no bill was present for action.

Car Storage Regulations were checked on by Mahoney. Custer Health is checking into this and will get back to him. Olin moved to table until next month. Rudningen seconded the motion, all voting aye, motion carried.
