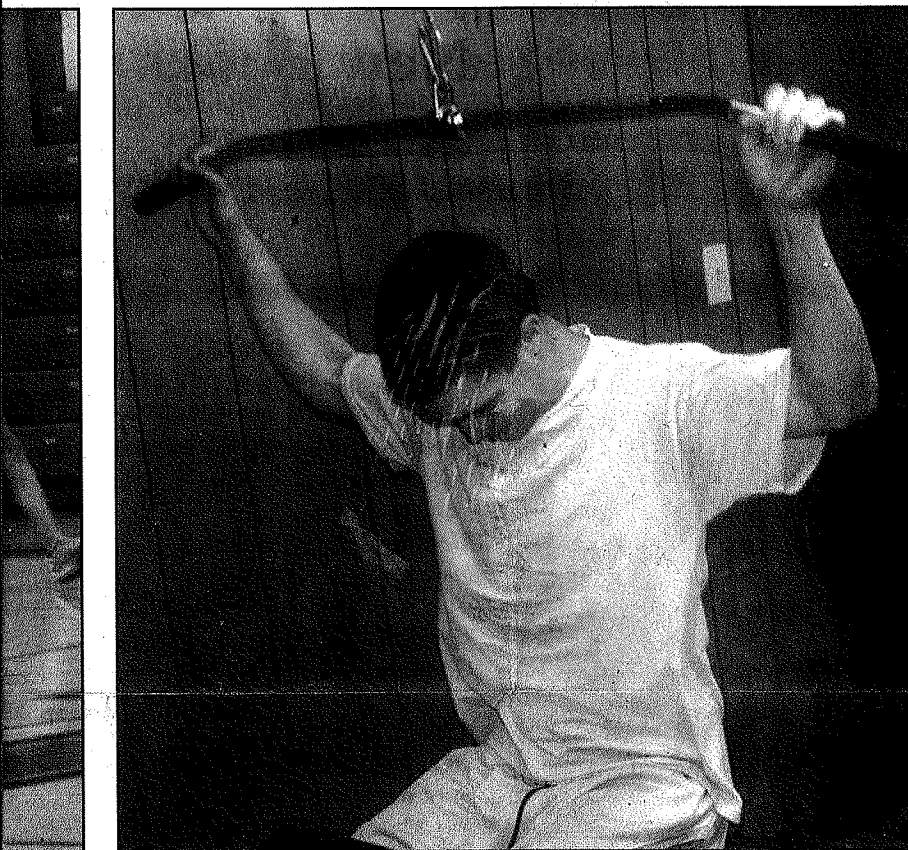
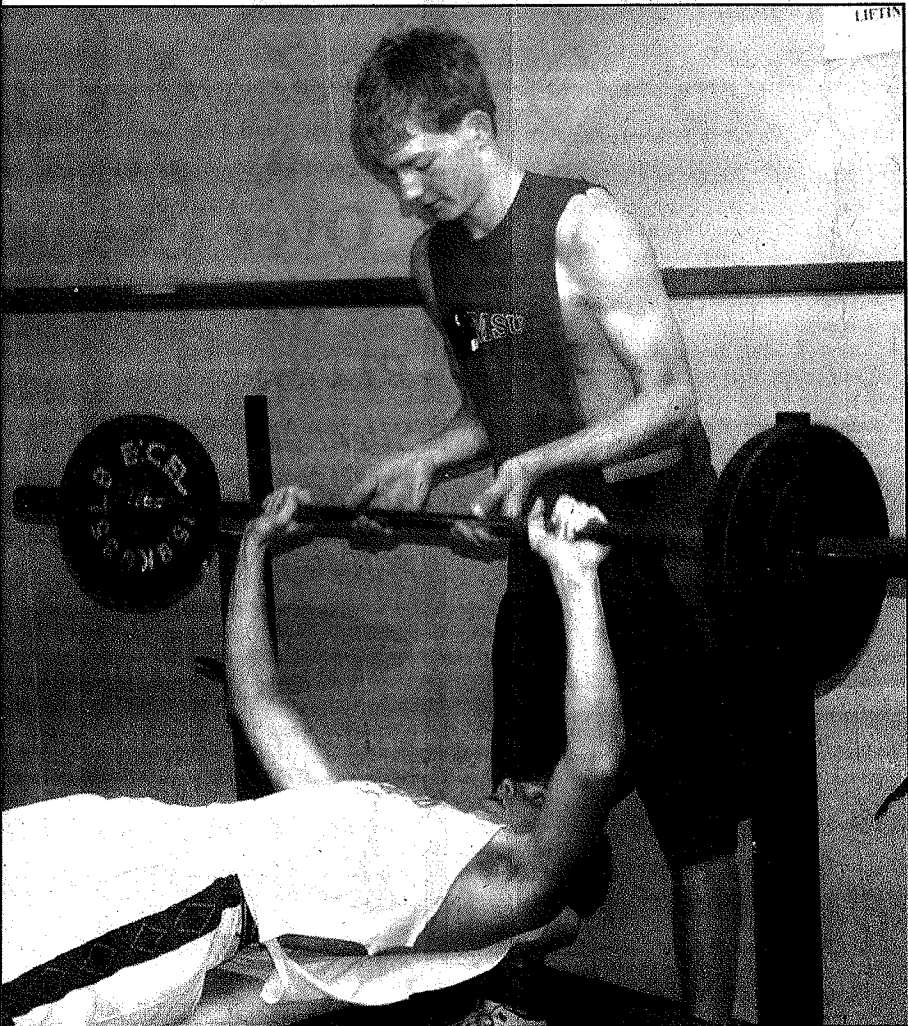

Legally drained wetlands that can be restored could offer Devils Lake watershed landowners financial rewards. The reconstruction of roadways, dikes and other infrastructure, due to rising water in Devils Lake, has created a need for wetland mitigation credits in the Devils Lake watershed. The watershed contains all of Ramsey County and portions of Towner, Cavalier, Walsh, Nelson, Benson, Pierce and Rolette Counties.
