HOW BUSY WAS 2015?

- ▶ 142,100 LOCATE REQUESTS
- ▶ 808,693 DISPATCHED LOCATE TICKETS
- ▶ 50% LOCATE REQUESTS WERE ELECTRONIC
- ▶ 19% OF ALL LOCATE REQUESTS REQUIRED NO INTERVENTION BY CENTER



COMPLAINTS IN 2015

- ▶ 12 COMPLAINTS FILED
- LEGAL PROCESS
- DAMAGE PREVENTION & SAFETY
- NOT ABOUT PENALTIES



PENALTY AMOUNTS

- \$1,000 first violation, with \$5,000 for each subsequent violation within 12 months
- Up to \$5,000 for the first violation and up to \$10,000 for each subsequent violation within 12 months of the initial violation, if it's considered intentional.
- Each violation is a separate offense. Each day the violation continues constitutes a separate violation.

- DUG ON PRIVATE PROPERTY/NO TKT 1
- DID NOT MEET ON HIGH PROFILE TKT- 1
- DUG ON EXPIRED TKT 1
- DID NOT LOCATE 1
- DUG B4 START DATE & TIME 1
 - NO LOCATE REQUESTED 7



DISPOSITION OF COMPLAINTS

- 1 WITHDRAWN BY THE COMPLAINANT
- 1 DISMISSED NO VIOLATION
- ▶ 10 ASSESSED \$500 TO \$1,500 IN PENALTIES



REPORTED DAMAGES

- 620 DAMAGES REPORTED IN 2011
- > 732 DAMAGES REPORTED IN 2012
- 727 DAMAGES REPORTED IN 2013
- 792 DAMAGES REPORTED IN 2014
- 864 DAMAGES REPORTED IN 2015



> ZERO DAMAGES IN 99% OF SITUATIONS WHERE A LOCATE WAS REQUESTED.



4,191 EMERGENCY LOCATE REQUESTS IN 2014

SDCL 49-7A-1

(3) "Emergency," an occurrence which demands immediate action to prevent significant environmental damage or loss of life, health, property, or essential public services including the re-erecting of critically needed traffic control signs or devices;



EXCAVATION DEFINED

SDCL 49-7A-1

(4) "Excavation," any operation in which earth, rock, or other material in or below the ground is moved or otherwise displaced by means of tools, equipment, or explosives, and includes grading, trenching, digging, ditching, drilling, augering, tunneling, scraping, and cable or pipe plowing or driving, except:



EXCEPTIONS

SDCL 49-7A-1

- (4) (a) Tilling of soil and gardening to a depth of twelve inches and the tilling of soil for agricultural purposes to a depth of eighteen inches;
- (b) Pot hole repair and grading of an existing public road if the pot hole repair and grading does not extend more than eighteen inches below the finished roadway;



EXCEPTIONS

- (c) Any vehicle operation or operation involving the use of any <u>hand tool</u>, other than a power tool, so long as such operation does not extend more than eighteen inches below the surface of the groundline within the right-of-way;
 - (d) Any road and ditch repair or road and ditch activity that does not extend more than eighteen inches below the surface of the original groundline within the right-of-way;



EXCEPTIONS

- (e) Digging in a cemetery;
- (f) digging in a planned sanitary landfill; and
- (g) Any bar test survey deemed necessary by an operator in response to a suspected natural gas, propane, or other combustible liquid or gas leak that is necessary to ensure public safety in an emergency;



EXCAVATION TICKET TYPES

ADMINISTRATIVE RULES – ARTICLE 20:25

- NORMAL (ROUTINE) 48 HOURS (HIGH PROFILE)
- ► EMERGENCY DEFINED IN LAW 2/4 HOURS
- UPDATE 48 HOURS
- RE-SPOT 24 HOURS
- MODIFY 48 HOURS
- ▶ APPOINTMENT 48 HOURS AFTER MEET
- ▶ VERIFICATION 2 HOURS ONLY TO VERIFY
- PROJECT REQUIRES CENTER SUPV APPROVAL



NON-EXCAVATION TICKET TYPES

- SURVEY ???
- PLANNING
- INFORMATIONAL
- DAMAGE REPORTING IS MANDATORY



REMINDERS

- REQUEST LOCATES
- HAND DIG WITHIN 18" OF MARKS
- REPORT ALL DAMAGES
- CALL 911, IF THERE'S AN ESCAPE OF GAS OR PETROLEUM PRODUCT



MORE REMINDERS

- REQUEST PRECISE AREA, NOT WHOLE LOT
- DON'T ALWAYS UPDATE A TKT CREATE NEW
- TAKE TKT TO SITE
- MANAGE LOCATE TKTS
- PRESERVE MARKS
- REMOVE LOCATE FLAGS
- VERIFICATION TKTS ARE NOT A SUBSTITUTE FOR RE-SPOTS
- SPACE LOCATE REQUESTS OUT SEVERAL DAYS



EVEN MORE REMINDERS

- BEGIN WORK ON OR AFTER START TIME
- MAKE SURE TICKET ISN'T EXPIRED
- FEDERAL LAW = MUST HAVE A LOCATE REQUEST IF WORKING AROUND PIPELINES
- FEDERAL LAW CALL 911 IF A GAS OR PIPELINE IS HIT
- SOMETHING...SAY SOMETHING!!!



LOCATORS

- INTRODUCE YOURSELF TO PROPERTY OWNER AND TO EXCAVATOR
- ▶ KIDS IN YARD ←RED FLAG TO PARENTS
- OVER SPRAY PAINTING FENCES, HOMES, AND LANDSCAPE ROCK
- LEAVE CONTACT INFORMATION


