AMENDED NOTICE OF FILING AND PUBLIC HEARING

April 9, 2020

A **Public Hearing** on the application in Case No. PU-20-082 was noticed to be located at the City of Williston Public Works & Engineering Department, 1121 5th Street East, Williston, ND 58801. Due to the state emergency, the **Public Hearing** will be held remotely to begin at **9:00 a.m. (CDT) on April 24, 2020**. Public testimony received by the Commission will be placed into the record for consideration. The Commission will receive testimony through the following methods:

Following the testimony by OE2 North LLC, on April 24, 2020, the Commission will call you back to receive your testimony in an order determined by the Administrative Law Judge. If you wish to provide documents or photographs for reference during your testimony, please provide them to the above-listed email or mailing address with a note expressing the intended use.

OE2 North, LLC (OE2) filed an application for a Certificate of Site Compatibility concerning the location of a 250 million standard cubic feet per day gas processing plant in Williams County, North Dakota, as shown on the attached map.

OE2 has also filed an application for a waiver of procedures and time schedules established under North Dakota Century Code sections 49-22.1-05, 49-22.1-06, and 49-22.1-10, and North Dakota Administrative Code Chapter 69-06-01-02, requiring separate

hearings on a waiver request and a Certificate of Site Compatibility application. OE2 has also requested to shorten the six-month period specified in section 49-22.1-06(5) of the North Dakota Century Code.

The issues in the application for waiver of procedures and time schedules are:


1. Are the proposed facilities of such length, design, location, or purpose that they will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?
2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues in the application for a Certificate of Site Compatibility are:


1. Will construction, operation, and maintenance of the facility at the proposed location produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Is the proposed facility compatible with the environmental preservation and the efficient use of resources?
3. Will construction, operation, and maintenance of the facility at the proposed location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

The Commission will consider written testimony received up to five days after the hearing to accommodate members of the public that are unable to attend due to coronavirus concerns. 

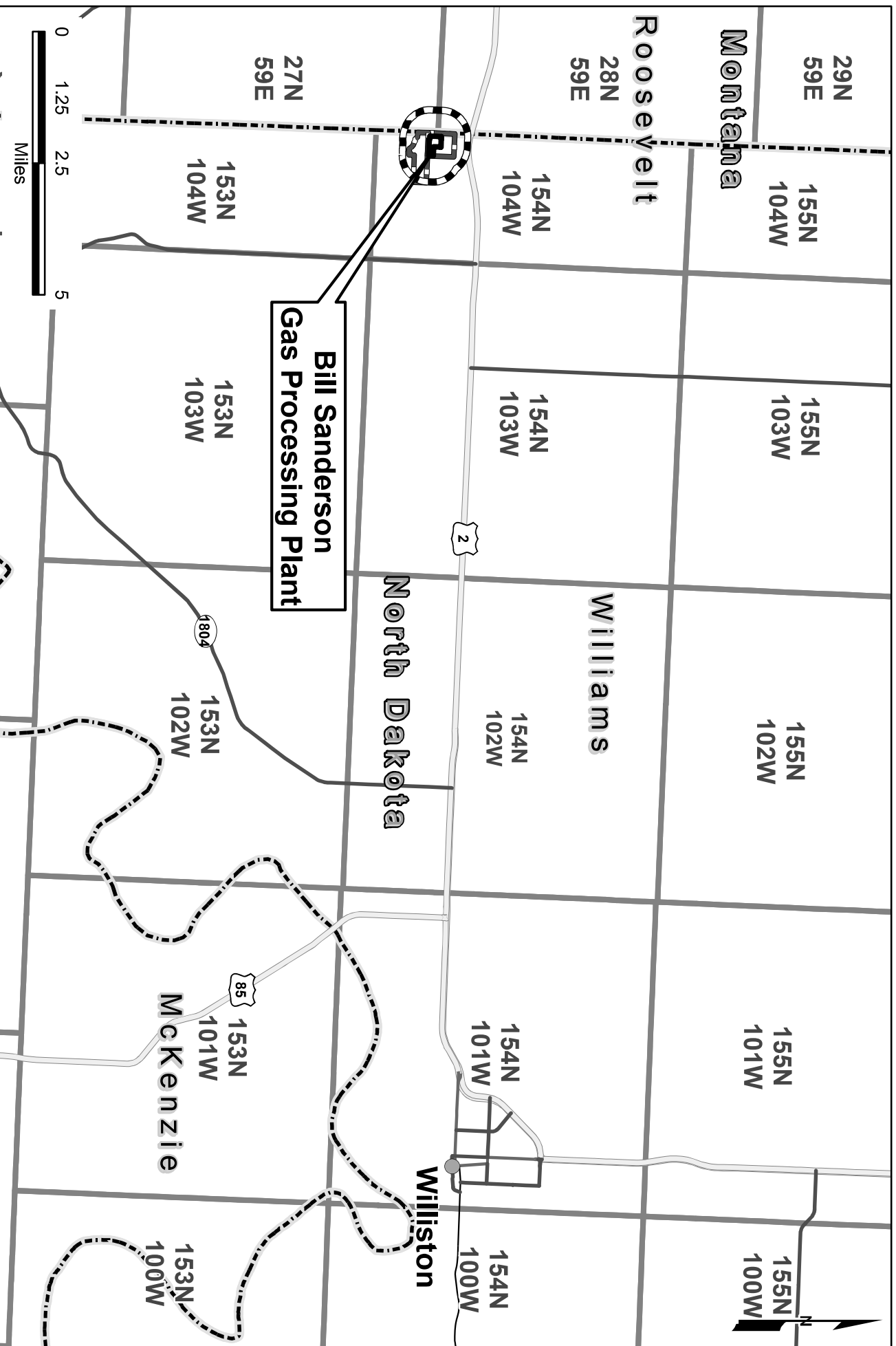
